








The Business Hub Provides business formation services as we are strategic partners with the governments and free zone entities in the UAE.





Involves registering a business with the Department of Economic Development (DED) of the relevant emirate by obtaining the necessary licenses and permits, registering the business with the relevant authorities, and meeting all legal and regulatory requirements.



An offshore company in the UAE is a business that is registered in the UAE for tax purposes while carrying on its business activities outside the country. They are limited liability companies, which means your finances are well protected. Opening an offshore business is an ideal, tax-efficient, and cost-effective corporate structure for entrepreneurs who wish to conduct international trade.

D Special Purpose Vehicle (SPV)

A SPV is a type of company that its shareholders set up for a specific purpose. SPVs are usually established to isolate financial and legal risks by ring-fencing assets and liabilities. SPVs can be established as subsidiaries, projects, or joint venture vehicles to ensure that only those assets related to a transaction are exposed to the liabilities associated with that transaction. Setting up an SPV in the UAE can either be done through the Abu Dhabi Global Market (ADGM) or the Dubai International Financial Centre (DIFC).





Adnoc Vendor Registration

The Abu Dhabi National Oil Company (ADNOC) Group is the national oil company of Abu Dhabi and is among the largest oil companies in the world. The ADNOC group awards multimillion-dollar contracts to local companies every year. Foreign companies can do business with ADNOC if they have their own company or branch in Abu Dhabi. Associating with ADNOC is possible only after getting registration approval. The ADNOC registration for vendors and suppliers is a mandate introduced to maintain and expand ADNOC's high-quality standards.



SPC (Supreme Petroleum Council) approval authorizes a company with the activity of "Onshore and Offshore Oil and Gas Field and Facilities Services" and is required when a company would like to work with ADNOC or any company attributed to ADNOC.



ICV (In-Country Value) Facilitation Services

As part of ADNOC's ICV program, all ADNOC suppliers are required to declare their ICV achievement (ICV Certificate) and their certified ICV score for the previous financial year, demonstrating how they are helping to deliver ICV. Business partnerships with ADNOC include an ICV assessment as part of the tender evaluation and award process.

Critical Infrastructure and Coastal Protection Authority (CICPA) security passes allow access to restricted ports and field sites. There are many restricted areas that are not accessible without the correct or relevant CICPA pass.
